Whole School Safety Overview



- In partnership with CPS and the community-led Whole School Safety Steering Committee, schools developed holistic safety plans around three safety pillars: physical safety, emotional safety, and relational trust
- Holistic safety plans are created by schools consisting of students, parents, staff and leadership, including the decision over whether or not to remove SROs
- Select high schools received reinvestment funding toward alternate safety strategies (\$3.9M annually). Examples include:
 - Restorative Justice Coordinator
 - Climate and Culture Coordinator
 - Counselor
 - Security Officer
 - Student Intervention Coordinator

What should Whole School Safety look like?

- What does safety mean to you?
- How do you know you are safe?
- When do you feel safe?
- Is there a place or someone that makes you feel safe?
- Why is safety important to you as a young person/student?




















Did your roundtable answer the question, "What should Whole School Safety look like?" 13 responses






Very Satisfied

Student Survey Feedback What is your biggest takeaway from the roundtable?

- All schools are different.
- Whole school safety is important; however, it can look different for different schools and has the ability to change the trajectory of a student's life.
- There are people who want to support our school community.
- CPS officials are really interested in our views and opinions.
- Our voices matter and they want to highlight our voices/perspectives.
- Adults are willing and excited to listen when an encouraging youth-led environment is cultivated.
- Adults do care about what makes us safe within our schools.
- The roundtable was a very new and welcoming experience. It is something I would want to do again.
- It's important to empower others to talk about their experiences.
- I felt seen and heard.



Lessons Learned

Here are key takeaways that we discovered and want to apply to the next Student Voice Roundtable:

- Morning preparation before the roundtable empowered student engagement
- Leverage existing resources for more students to attend roundtables
- Continue to be cognizant in representing diversity of schools, ethnicity, background, gender, etc.
- Perspectives about safety can be different between adults and students
- Continue to brainstorm methods to make the roundtables more accessible and convenient for students to participate





There should be timely, regular, and frequent communication between CPD and CPS to proactively flag safety concerns in schools' surrounding neighborhoods.

Implement methods of accountability to ensure school security staff are properly and adequately trained to support students holistically.





Increase accountability for Safe Passage workers and hire additional crossing guards to help maintain student safety to and from school.





Create and implement relevant trainings for all staff to help maintain a safe school environment.







Establish accessible resources and clear protocols dedicated to encouraging, restoring, and maintaining mental health for staff and students.





Offer regular opportunities, during school hours, for students to voice how safety affects their experience in their school communities.





Hire additional staff in social-emotional learning (SEL) positions and ensure that all schools have knowledgeable and supportive SEL staff.

Continue to shift the District's mindset from the negative connotation of neighborhood schools.







Establish and implement better, clearer procedures that enhance communication with students and families about active crises within the school building and surrounding neighborhood.

Determine methods to uncover root causes of discipline issues and authentically employ restorative practices in all schools.


- Clarifying questions serve the purpose of helping the asker better understand what was shared/presented.
