- waiting four years to come to a determination in the investigation of the now former Student Protections Chief Camie Pratt. Pratt was allowed to stay in her position for 4 years and possibly taint other investigations.

- the investigation of 14 CPS employees (all African American) for PPP loan fraud when the money didn't involve CPS money. Fletcher reported more fraudsters were under investigation, but, never reported more of them out of the 43,000+ CPS employees
- utilizing a unique analysis of CPS inventory records to determine 77,505 laptops and tech devices were missing or lost and his report failed to give a school-by-school breakdown of the inventory lost or missing. And, CPS claims to have no responsive records of the losses by each school and Fletcher still claimed 77,505 laptops or tech devices were missing or lost. How's this possible?

Were these 'Hollywood' investigations, for show and to thwart a federal takeover of CPS and Fletcher's IG office? It sure seems that way.

Why did it take Fletcher take four years after a complaint was made against Pratt and according to the investigative file, two years after the last interview to recommend Pratt's termination? Most CPS employees under investigation are put on suspension until an Investigation is completed, why wasn't Pratt removed from her position immediately? Instead, Pratt's CPS salary history shows that not only wasn't she suspended, but she received five raises since the investigation began (topping out at \$207,199) with three raises after the last interview in the investigation of her.

After i filed IARDC complaints https://www.iardc.org/ against several evil attorneys at CPS, many of them resigned from CPS and left the state of Illinois like former Inspector General William Fletcher and former title ix coordinator Camie Pratt (they were evil people trying to turn a victim into a respondent) and they've committed many crimes such as moral turpitude.
