1	MAKE ROOM FOR DEBATE! I am an alumnus of the Chicago Public Schools Debate League. I attended Lane Tech High School and was the founding debate captain. The skills I learned in debate - critical thinking, analysis, persuasive speaking - were crucial to my academic success in high school and in college. I went on to debate at the University of Chicago, and am currently completing my Ph.D. in sociology at the University of Michigan. Without debate, I never would have had the confidence to go to college, as I am a First Gen from a low-income background. However, debate exposed me to numerous college student mentors and high school debate coaches who made my dreams a possibility through their hard work and dedication. Please fully fund the debate program, thousands of alumni are counting on the Board to maintain it's commitment to debate.			
2	We are in the middle of a covid surge, and I am deeply concerned about the lack of precautions that schools have taken. It seems like everyone has decided that vaccines magically fixed everything, and children with underlying conditions are being left behind. Not everyone has the immune system to fight off this virus, and they're basically being told that their lives are an inconvenience. I'm begging for some simple precautions, like masking, free covid testing, and not overcrowding classrooms (which also benefits ALL the children and the teachers!). Simple precautions can save lives, and if precautions had been taken, my grandmother would still be alive. How many children live with immune vulnerable caretakers? Please show consideration for the most vulnerable among us.			
3	I am writing to submit a comment regarding the safety of CPS students and staff. Given the summer surge of Covid-19 cases and the upcoming flu season, I believe that several steps should be taken to ensure the health and safety of students and staff, particularly those living with a disability, is prioritized. I suggest the following measures be implemented when possible: distribution of free N95s/KF94s masks, free on-site PCR opt-out testing or multiple rapids to test when asymptomatic, on site Covid vaccines, allotted time for absences until two negative Covid-19 tests are done, air purifiers in areas where people congregate, open windows, and having lunch outdoor.			
4	It is terrifying that parents and teachers should be put in a situation of having to choose work/education versus health and safety. We should be doing everything possible to make sure that both are as safe as possible. That the most vulnerable are protected and that everyone is educated on the true risks of Covid. Between this and the lice policy it seems like the school board wants to ensure that the families of school children and teachers and staff get sick and remain that way especially when our BIPOC and poor and unhoused neighbors are the most effected. This is Eugenics at it's core and we need to do better.			
5	As a parent of two students at the Interamerican Magnet School (IAMS), I am compelled to add my voice to the many parents and teachers who are deeply concerned with choices made recently by the current Principal. It is not acceptable that this year, 1st graders have two classrooms, instead of the normal three. The resulting overwhelming class sizes (28 and 29) negatively affect students and put strain on teachers. 1st grade is a critical time for young learners, especially in developing reading comprehension, etc.			

	All other grades PreK-5th have three classes, so not prioritizing the addition of another teacher/classroom is highly unusual. It also seems the current Principal unilaterally decided (against teachers and the LSC's recommendation) to replace dance and library with an MTSS teacher. To make matters worse, there was almost zero communication from the Principal about any of these changes until days before the school year started. I was dismayed to hear firsthand that due to these changes and a complete lack of transparency, some teachers have already left IAMS or plan to because of this recent mismanagement. I am deeply disappointed and concerned with the Principal's apparent dismantling of a quality school where teachers and students are valued. I understand that budget cuts are necessary, but there is more than one solution to this challenge that would not result in getting rid of a core teacher position. Creating 1st grade classrooms of 28+ is negligent, especially in a bilingual setting. We must provide an additional teacher's assistant.
6	Im a parent from interamerican, my son is in 1st grade and this year he classroom size has increased from 18 to 28 kids. My son has a 504, he has ADHD and this decision made by principal zayas has been a violation against teachers, students and school. I am so concerned about my child education this year. How he is supposed to learn with 28 classmates and just one teacher? I ask to intervene because Mr zayas has been neglected to work with the school community and made decisions without following the usual protocol. We need al least a teacher assistant or another 1st grade class. This decision is not inclusive and affects everyone specially kids like mine.
7	What is happening with transportation funds and getting children with IEP and general
8	Ed students to their Magnet and Selective enrollment schools I'm writing currently in the hope that personnel such as the Board of Education itself in this great city, and the residents of said city for whom this comment might find itself in the presence of, may enact change the likes of which are paramount to the very function of an educational environment in the first place.
	The past four years have not been kind to the pursuit of education for any child in the world, let alone those in the city home to the second American patient to succomb to a SARS-Cov2 infection. In the wake of the one becoming the hundreds, thousands, and eventually, millions who have fallen, as further afflictions rise to threaten our wellbeing, I ask you not turn a blind eye to those responsible for your future, to those who will someday care for their offspring as we do ours at this moment. We have myriad a data point showing the efficacy of masks in the wake of respiratory illness, and vaccination in the wake of all illnesses for which we have one. And while I acknowledge such preventative methodology must be implemented carefully and with regard to a budget that is rarely adequate, I feel preventing the spread of a plague which not only maims indescriminately, but is also indiscriminantly lethal, to be paramount to the wellbeing of our very future, of our children's future.
	So I ask with the hindsight of the logistical nightmare remote education was that you not faulter where one of the subjects these students will study has proven itself, with the distribution of N95 or equivallent masks, with the distribution of tests available for SARS-Cov2, with the assurance children who test positively, sympyomatic or not, avoid placing their education in jeopardy when they are sent home, and with distribution of vaccines for such ailments as they become available. Parents of young and old and yesteryear have voiced their dissent to what I propose, yet offer no proven solution of their own. I

ask you please not indulge them for the sake of their own children's future as much as ours.

9	I would like to suggest that School Bus drivers who are also certified subtitute teachers be able to sub if needed at the schools they service on their bus route. I also am suggesting again that certain schools be used as ESL hubs where space is much
	available to bring sources toether in one place to serve more students outside g neighborhood bounderies.
10	Covid 19 never went away, and we are coming out of the largest national Covid surge in
	the past two years. As the weather gets colder, we can expect things to get even worse again. While we know that Covid and Long Covid are harmful for everyone, there are so many unknowns as to how this virus affects children as they grow and develop. We have an ethical responsibility to protect our children from the horrors that have been made clear in the scientific and medical literatures regarding Long Covid, in addition to protecting them from whatever unknowns are lurking out there regarding Covid. We are adults, and we must keep them safe. We can't continue to treat them like guinea pigs in an unmitigated global pandemic. Failure to keep children safe from Covid with the methods that we know to be effective, such as respirators and HEPA is a type of neglect that has no excuse.
11	I believe that CPS must return to stricter mitigation around Covid-19 in order to protect
	the health of students and teachers. What I believe this looks like is distributing
	respirators (KN95/KN94/etc), having PCR testing available, distributing rapid tests to improve asymptomatic detection, and on-site Covid-19 vaccination when new vaccines
	are available.
12	CPS, as well as parents and community members, have an obligation to protect children
	from COVID. This includes CPS-driven measures to offer: free N95 or KN94 masks, free
	on-site PCR opt-out testing or multiple rapids to test when asymptomatic, and onsite Covid vaccines when the new variant is available.
13	Please protect the students and staff by requiring and providing respirator quality masks,
	such as N95s/KN95s/KF94s or equivalent; as air filtration through air purifiers or corsi
	rosenthal boxes; and PCR testing. We are in the biggest COVID surge yet, as shown by
	wastewater scans, and as people get more and more infections, their immune system and overall health suffer, putting them at risk for disabling conditions like dysautonomia,
	chronic fatigue, cognitive decline - all of which I have suffered after a single infection,
	which I got from the students I worked with, while I was the only one masking. Masks are
	effective at stopping the spread of disease, even if they aren't perfect, but they can only
	do so much alone. They are near perfect when everyone is masking. Please protect the safety and health of our future. I do not want to see the next generation suffer from
	preventable illness, disability, and deaths.
14	I have asked the principal to request a crossing guard at her school for several years,
	because the school starts earlier than other CPS schools in the area. My son almost got
	hit by his former teacher, because she ran the stop sign, her staff continues to run the stop sign and today, 08/28/2024 was no exception. I am reaching to anyone who will
	listen, or point me to the right administration.
15	Please have free N95 and KF94s in school, free PCR opt out testing, on-site COVID-19
	vaccinations for the new variant (2024-2025) and rapid testing available to test staff and
	children, even if they are asymptomatic.

I do my best to try and address the Board as often as possible because pointing out problems with CPS and offering solutions through public comment is the only option I have. However, you have a lot of power and influence based on the position that you hold. The vast majority of you will not be here in a few months, so the ultimate question before you is how will you use your significant power in the limited time you have on the Board.

Budget

We don't have a budget that's sustainable or a transparent system that is equitable. You still need to share the details of school-level budgets or funding formulas. I have tried for months to receive those public records from your bureaucrats that have fought me, and I work hard to get what I want. Every day, I gain more insight into your operations and discover some interesting things. The formulas you use pit Black and Brown students against each other, just like your flawed tier system. I have told you before that your budget significantly underfunds schools that serve primarily Latino students and you have allowed this discrimination to persist.

This new "equitable" funding formula has unintended, but not unforeseen, consequences of hurting schools that serve students with disabilities. There are also miscalculations. You are not Nikki Giovanni; your mistakes are wrong, and your errors are NOT correct.

Busing

Why am I here every year pointing out that you are not meeting your legal obligations to transport students with disabilities? Why are you paying more money to transport fewer students? Why are you just reporting on the 1,155 students with disabilities who don't have transportation, but why are you not reporting on the transportation of students based on Least Restrictive Environment (LRE)? Why are you not reporting on the students enrolled in cluster programs that aren't being transported? I offered to help and do the routing with you. I wouldn't criticize you if they did their job well. Focus on students with the greatest need and get them routed. This can be achieved by offering financial reimbursement for families that can arrange transportation for a student with a disability. That would lower the number of students requiring busing and is less costly than arranging transportation with companies. Make sure students who have the highest LRE needs are taken care of first because those are the ones who are most negatively impacted by being shut out of school. Students with the greatest need for accommodations should be routed before those with limited accommodations, although you have a legal obligation to transport all students who need it. Finally, you should engage with the Special Education Advisory Committee. Remember: *Nothing about us, without us!*

With the limited time you have, use your power to bring accountability and do right for our students.

Below are some policies you are considering this month that should be revised.

Volunteer Policy:

The proposed revisions to the volunteer policy with further limit opportunities for engagement with schools that serve low-income students. Creating unnecessarily bureaucratic hurdles will only make volunteers less likely to engage. Moreover, it creates additional work for schools for

such limited reward. Having parents or other trusted members of the community to speak to children in supervised settings should not require extensive training. As a level I volunteer, I have no problem with extended background checks, fingerprinting, or TB tests (although their utility is questionable). But that is my choice to be able to volunteer in an extended capacity. Schools need volunteers that serve, this policy makes it harder for us to do that.

Breakfast After the Bell Policy

This policy will have unintended consequences that the District fails to consider. Breakfast After the Bell (Public Act 99-0850) is a requirement for public schools that serve at least 70% low-income students. The District provides no cost analysis or takes into account the negative impact that breakfast after the bell will have on classroom engagement.

Paid Time Off Policy

This policy creates an incentive for employees to use their leave at the end of the school year, concentrating the need for substitutes during a small window of time at the end of the year. The policy provides no cost analysis to examine other strategies, including a partial payout or partial gifting of unused sick days.

Dear Chicago Board of Education Members,

The start of a new school year is always an exciting time for everyone. We are all dedicated to ensuring that our students, families, and staff are supported and prepared for a successful year of learning and growth. However, this year feels different for many of us. The ongoing contract negotiations with the Chicago Teachers Union (CTU) and news reports of a potential leadership change involving CEO Pedro Martinez have created an atmosphere of uncertainty. While our primary focus remains on our school communities, we feel it is important to share our concerns as principals and assistant principals as the school year begins.

We, the Principals and Assistant Principals from across the City of Chicago write to emphasize the importance of stability within an institution. Every school administrator knows that significant changes at the beginning of the school year can be detrimental to the students, staff, and families we serve. That is why we ask you to carefully consider the potential impact that a change in leadership could have on the Chicago Public Schools community.

We understand the political dynamics at play—the Board of Education hires the CEO, and the Mayor appoints the Board members. It is also widely recognized that there is a connection between Mayor Johnson and the Chicago Teachers Union. Nevertheless, decisions about CPS leadership should not be driven by political affiliations or interests. We urge the Board to focus on the long-term success of the district and the needs of all stakeholders by acknowledging the impact the current CPS leadership team has had on our district.

No leadership structure will ever satisfy everyone completely. Just as teachers may raise concerns with principals, and principals may raise issues with Network Chiefs, disagreements are a natural part of the organizational process. That said, it is important to recognize the inclusive and collaborative culture that CEO Martinez and Chief Education Officer Bogdana Chkoumbova have cultivated. This shift has been acknowledged by both seasoned leaders and those new to the role. Principals across the district have developed a professional rapport and a trusting relationship with the current CPS leadership which has allowed us to work collaboratively to create the best schools for all students in Chicago.

Under the current leadership, the district has prioritized several key initiatives, including early literacy, career and technical education (CTE) programming, a needs-based budgeting process that provided a transparent way on how schools are funded and why,

enhanced school safety, and improved student outcomes through a high-quality curriculum. These initiatives demonstrate a commitment to collaboration between district leaders and administrators to better support teachers, staff, and students.

Leadership transitions inevitably bring change. However, this letter is not driven by fear of change, but rather by the belief that such a change is unnecessary at this time. We strongly urge the Board of Education to allow CEO Martinez to continue leading the district as he has for the past two plus years. We need to maintain the momentum behind the initiatives already underway that have been successful due to the support CEO Martinez has gained by listening to and trusting school leaders to give guidance on what is best for schools.

While we are represented by the Chicago Principals and Administrators Association (CPAA), this letter is written independently of CPAA due to ongoing negotiations between CPAA and CPS. Our intent is to ensure that the voices of school leaders, who are deeply invested in the success of our students and schools, are heard.

We trust that the Chicago Board of Education will make decisions that are in the best interest of all CPS stakeholders. This includes the school leaders who are charged with fostering the academic and social-emotional growth of our students. We respectfully ask that you allow CEO Martinez to continue his leadership and the important work that is positively impacting our district.

On behalf of Landmarks Illinois, I ask the Chicago Board of Education to approve the sale of the Former School Building C of George Washington Carver Primary School to People for Community Recovery. Landmarks Illinois proudly supports People for Community Recovery's vision to transform this vacant school building into the Hazel M. Johnson Institute for Sustainability and Environmental Justice.

School Building C, constructed in 1944, was one of four original school buildings forming a complete educational campus centered on a park at the center of Altgeld Gardens. It served as Altgeld's high school until 1950. It has now been vacant for over thirty years. In 2021, Landmarks Illinois included School Building C on our list of the Most Endangered Historic Places in Illinois, calling for renewed investment in this important community asset.

As the Hazel M. Johnson Institute for Sustainability and Environmental Justice, School Building C will once again contribute to community life at Altgeld Gardens. The National Register of Historic Places-listed building will be rehabilitated and will offer programming that centers Altgeld Gardens' history as the birthplace of the environmental justice movement. The building's new use as a center for learning and research will honor its educational origins and amplify People for Community Recovery's leadership in environmental justice and sustainable development.
